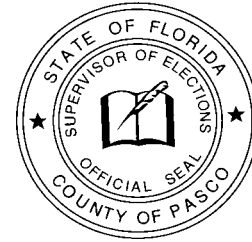

PREPARATION IS KEY TO SUCCESS

Voter turnout in the General Election is expected to be considerably higher than the 20 percent turnout recorded in the August Primary Election. This aspect contributes to the importance of electors being aware of their responsibilities in experiencing a hassle-free election.

Voters should make sure their record is up-to-date including their signature. They should remember to take photo and signature identification to the polls and utilize their sample ballot while voting. They should also become familiar with the iVotronic touchscreen voting system used in Pasco County.

Public demonstrations of the voting equipment are held throughout the county on a regular basis. Pasco County residents are encouraged to acquaint themselves with the equipment at one of these demonstrations. While demonstrations are available at the polls, we recommend they familiarize themselves with the equipment at a demonstration or in one of our three offices before Election Day.

Local businesses, civic organizations, clubs and committees can help the efforts of the elections office by inviting our demonstrators to attend their regularly scheduled events. If your organization or group would like an in-depth presentation or demonstration of the iVotronic voting system, please contact the elections office. We will be happy to send the equipment and staff needed to accommodate your request.

ON THE ROAD AGAIN

Pollworker Training Sessions

night workers. Each training session is designed to equip election workers with the tools necessary to perform their jobs on Election Day.

Mr. Browning believes that the positive results Pasco County experiences on Election Day stem from the methodical training of his volunteers. This is why Pasco County puts a lot of time and effort into developing a top-notch training program, including in-depth PowerPoint presentations, intensive “hands-on” equipment training, state of the art video instruction, and user-friendly training manuals. The elections crew will head out again on October 1st to begin the final



round of training sessions for the 2004 election cycle. By October 28, 2004, the elections office will have conducted nearly 120 training classes since preparation began for the March 9th Presidential Preference Primary. The election's office applauds the commitment of the volunteers who attend the trainings and provide quality service on election day. ■

An Emergency Plan...

Formulating possible solutions and outlining a course of action

For years, we have skirted the impact of a major storm that would force improvisation of the election process in Pasco County, a remarkable fact considering hurricane season and election season parallel each other. With the passing of Ivan, we can once again exhale, but Frances brought to life the necessity of having a "Plan B". As many areas of the county continue to dry out from heavy rains, Mr. Browning and the Emergency Operations Center are working to finalize our emergency plan in case the next storm is not so kind.

The only impact Pasco County elections suffered from Hurricane Frances was the structural damage and relocation of one polling place. That was not the case in Charlotte County which was devastated by Hurricane Charley just 2 1/2 weeks before the August 31st Primary. Fortunately, very little voting equipment was damaged, but in the aftermath, the few polling places still standing were being occupied by the Red Cross and the Federal Emergency Management Agency.

Charlotte County had to quickly make arrangements to accommodate their normal 80 precincts. Sixty-three precincts were divided among 9 locations, mostly churches, where "Super Polling Places" were set up that served 9-11 precincts each. Voters were notified on local radio stations and in the newspapers when sample ballots were published. Thirty voting machines were used at each location. In addition, 17 regular polling place facilities that survived the storm were utilized to accommodate 2-3 precincts each.

One of the biggest challenges was locating the pollworkers who either fled from the storm or sought temporary lodging after their homes were damaged. Charlotte County Supervisor of Elections Judy Anderson utilized local radio stations to notify her pollworkers who were MIA. What began as a hopeless situation ultimately turned into an overwhelming response from dedicated pollworkers who came forward. All who were willing to work were given assignments.

Nine regular office staff members, some of whom had lost their homes, came to work every day and faced the challenge of increased absentee ballot requests and Early Voting. Early Voting in Charlotte County was available just one week after Hurricane Charley and due to the late start, continued 12 hours a day, 7 days a week, through 5:00 p.m. August 30th.

Against the odds, and through the resourcefulness of a dedicated staff and help from the Division of Elections in Tallahassee, Charlotte County managed an honorable primary election. In the words of Judy Anderson, no emergency plan could have foreseen the obstacles to be overcome. Just the same, it can't hurt to formulate possible solutions and outline a course of action beforehand. ■

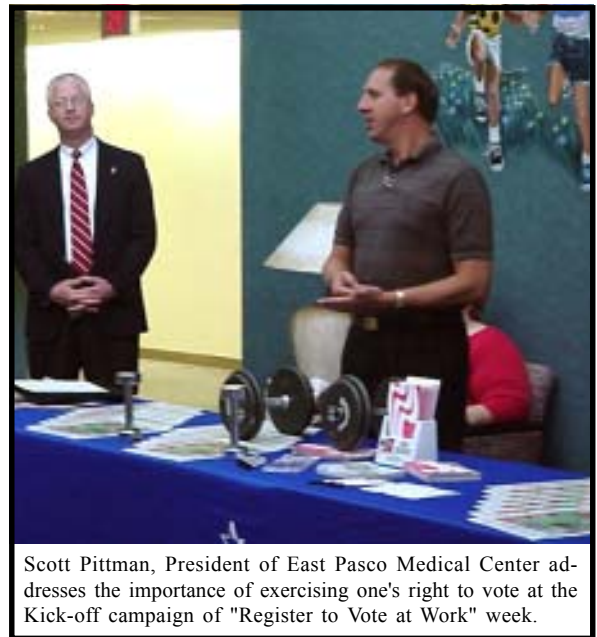

EARLY VOTING

Pasco County will begin early voting on Monday, October 18, 2004 and end on Monday, November 1, 2004. Early voting will be available in all three Supervisor of Elections offices during normal office hours on Monday, Wednesday, and Friday. On Saturdays, the hours will be from 9:00 a.m. until 5:00 p.m. Extended hours are available on Tuesdays and Thursdays.

Early voters will be using the iVotronic touchscreens to cast their ballots. Mail ballots will also be available. The initial mailing of absentees for the General Election is scheduled for late September. Voters interested in voting by mail should call the elections office at their earliest convenience, 1-800-851-8754. ■

During the recount, members of a counting team were given instructions on examining Under Votes on absentee ballots. The Member School Board, District 2 race had 4,150 Under Votes.



CALL CENTER VOTER INFO HOTLINE

The Pasco County Supervisor of Elections office takes pride in being one of the best elections offices in the state.



In our continuing effort to improve the elections process, this election cycle, we implemented a

call center to serve as an information source for voters. The call center was operational during the month of August and will resume again in October.

The 2-month pilot program employs eight telephone operators who respond to voter questions. After attending two days of training, the call center began fielding routine calls regarding voter registration and polling place information as well as processing telephone address changes and inputting absentee ballot requests.

This new service proved to be a win-win situation during the Primary Election. Calls were answered quickly, voters were efficiently served and the elections staff was able to concentrate on assigned tasks and assist people at the counter. This in turn decreased the amount of overtime and the resultant stress that goes along with the long hours associated with an election.

The call center is located at the Election Support Center in Dade City, the site normally used as the Election Day phone bank. The individual operators and elections office staff managing the call center are looking forward to getting back in the game and being a part of the process that will restore the reliability in Florida’s elections. ■

CONSTITUTIONAL AMENDMENTS

Each election year this office receives hundreds of requests for information, explanations, and the political position of individual ballot issues. The Supervisor of Elections’ office is prohibited from offering an opinion concerning any of the issues. However, we can direct voters to the resources available to conduct their own research.

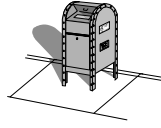
